PERSONNEL

Approval of Begindergarten Position

The Board of Education approves the employment of all personnel. The AEA agreed to allow the B-K teacher (Tanya Steinhaus) not to be part of the AEA salary schedule, due to funding. We currently have 11 students signed up for B-K. Tanya Steinhaus has agreed to accept the B-K position. She has taught for us at Orchard Primary before being laid off. She will do an excellent job in the B-K program. Program will be self funding.

Approval of Pre-School Position

Approval of Handbooks

The Board of Education approves the Student Handbooks of each school. The policies and procedures contained in the handbooks serve as a guide for our students. By approving `changes to the handbooks, the changes become a part of District policy.

- 1. High School Student Handbook
- 2. Orchard Primary Handbook

Approval of Overnight Trip Resolution

The Board of Education must approve student trips which require an overnight stay or involve out of state travel (Policy 2340).

The High School's various athletic teams have the opportunity to participate in tournament competition. Some of the tournaments (usually the MHSAA's State Tournament) require our students to stay overnight at a location outside of the Almont School district service area. In addition, several of our extracurricular clubs (ex. Quiz Bowl Team, Band, Choir) have the opportunity to participate in competition as well, some of which can require an overnight stay.

We have experienced difficulty in getting overnight trip requests/information in a timely manner in the past. Due to the timing of certain trip opportunities and the need to coordinate such matters as accommodations, meals, means of transportation, chaperones, itineraries, etc., the necessary information is not always available prior to the scheduled Board meeting.

For the past seven years, we have utilized a general resolution, brought to your attention early in the year, which would approve overnight trips for extra-curricular groups ahead of time. The resolution includes provisions directing the administration to provide the Board with trip information, i.e. accommodations for food/lodging, means of transportation, chaperone list and trip itinerary.

The resolution is intended to cover overnight trips which arise unexpectedly (team wins a district contest, next playoff game is at a regional location). Overnight trips which can be planned over time will still be brought to the Board's attention in a timely manner for approval.

Approval of Teacher Discipline Policy

The Board adopts bylaws and policies for organization and operation of the Board and District. Bylaws and policies may be adopted, amended, and repealed at any meeting of the Board, provided the proposed adoption, amendment, or repeal shall have been proposed at a previous Board meeting and, once, proposed, shall have remained on the agenda of each succeeding Board meeting until approved or rejected (Bylaw 0131.1).

The new policy will be recommended by the District's legal counsel (Thrun Law). This policy is needed since the teacher new legislation, (Pa 103) law requirements.
