Consideration of Policy Updates

The District's policy service (NEOLA) has provided a number of policy replacements, policy revisions and new policies for the Board's consideration. After considering these policies this month we will act on them in June.

Bylaw 0168.1 - Open Meeting (Revised)

This revision clarifies that minutes can be approved at either a subsequent regular or special meeting.

Policy 2221 - Mandatory Courses (Revised)

Recent legislative changes require school districts to include age-and grade-appropriate instruction about genocide. The legislature recommends a combined total of 6 hours of this instruction during grades 8 to 12.

Policy 2461 - Recording of District Meetings Involving Students and/or Parents (New)

This new policy provides the structure for districts to limit unauthorized recordings of meetings and other interactions with district personnel.

Policy 2623 – Student Assessment (Revised)

This policy has been revised to bring specific test references up to date with current requirements.

Policy 3120.04 - Employment of Substitutes (Revised)

This policy has been revised to clarify the districts' rights and obligations under the statute with respect to the employment status of substitute teachers.

Policy 3121/4121 - Criminal History Record Check (Revised)

These policies have been revised in order to be consistent with compliance requirements of the Michigan State Policy/Federal Bureau of Investigation (MSP/FBI) requirements for access and handling of criminal history record information.

Policy 5330.02 – Opioid Antagonists (New) – SUGGESTED BY NEOLA REP TO TABLE THIS ONE

Districts should adopt this policy if they intend to train personnel to administer opioid antagonists as allowed under the newly enacted law.

Policy 5517.01 - Bullying and Other Aggressive Behavior toward Students (Revised)

The revisions to this policy are optional and are based on changes to law, which "encourage" Districts to include provisions for considering use of restorative practices in its anti-bullying policy.

Policy 5610 - Emergency Removal, Suspension, and Expulsion of Nondisabled Students (Revised)

The revisions to this policy require consideration of specific factors when making decisions relating to suspensions and expulsions.

Policy 5610.01 - Expulsions/Suspensions - Required by Statute (Revised)

The revisions to this policy include the consideration of specific factors as in Policy 5610 and standards for assessing weapons violations.

Policy 7540.02 - Web Content, Services and Apps (Revised)

The revisions to this policy add a reference to the newly passed Student Online Personal Protection Act

Policy 8330 - Student Records (Revised)

The revisions to this policy were made to comply with the new law, which prohibits the sale of personally identifiable information that is part of a student's education record (with noted exceptions).

Policy 8400 - School Safety Information (Revised)

The revision to this policy was made to reflect the change to law, which was made in conjunction with the changes to suspension/expulsion.

Policy 8500 - Food Services (Revised)

Revisions to this policy are in response to the requirements of the United States Department of Agriculture (USDA) regarding bad debt and unpaid meal charges.

Policy 8510 - Wellness (Revised)

Revisions to this policy are in response to the issuance of the final rule of the Healthy, Hunger-Free Kids Act by the USDA

Policy 5111.01 – Homeless Students (Replacement)

Policy 5111.03 - Children and Youth in Foster Care (New)

Policy 8340 – Letters of Reference (Revised)

The revisions to these current policies as well as the new policy, reflect the current state of federal regulations.

Policy 8300 – Continuity of Organizational Operations Plan (New)

The primary objective of the COOP policy is to provide a structure whereby key District personnel can work together to identify the steps to be taken to restore the District's critical operational functions and the learning environment as quickly as possible after a crisis or threat event has occurred.

Policy 8305 – Information Security (New)

Board of Education determines the 3 classifications of data/information. The policy requires all individuals who may be granted access to *Information Resources* to certify annually that they will comply with the established security protocols.
